

# LIQUOR AND GAMBLING LICENSING FEES (2025-2026)

**LIQUOR FEES:** Columns highlighted in green refer to application for grant of a premises licence and fees are set by legislation.

Type of Fee	Current Fee
Category 1 - Premises fall within Category 1 if:-	Application Fee - £200
(a) they are not entered on the valuation roll or there is no rateable value or a nil value shown in respect of them on the roll;	Annual Fee - £180
(b) their main function is to provide a visitor attraction and any sale of alcohol on the premises will meet the following requirements:-	
(i) the alcohol is not to be consumed on the premises; and	
(ii) the sale of alcohol is considered by the Licensing Board as likely to be incidental to other activities carried on in the premises;	
(c) they are used wholly or mainly for the purposes of a members' club; or	
(d) their main function is to provide accommodation, they are only open to the public for the provision of accommodation and any alcohol sold on the premises is to be consumed on the premises by guests being accommodated there.

Category 5 Premises Licence Fee – Rateable value between £70,001 and £140,000	Application Fee - £1,700
	Annual Fee £700
Category 6 Premises Licence Fee – Rateable value over £140,000	Application Fee - £2000
	Annual Fee - £900

Application for confirmation of provisional premises licence	Fee will depend on rateable value of premises (less £200 paid for provisional application)
Transfer of premises licence on application of licence holder, including an application for variation of a licence.	£146.23

Transfer of premises licence on application of a person other than the licence holder, including an application for variation of licence	£146.23
