- 2. In this Order the following expressions have the meanings hereby assigned to them:-
 - "vehicle", unless the context otherwise requires, means a vehicle of any description and includes a machine or implement of any kind drawn or propelled along roads, whether or not by mechanical power.
- 3. No person shall drive any vehicle at a speed exceeding 20 mph on the lengths of road specified in Schedules 1 and 2 to this Order.
